# **BUSINESS OF THE CLERK** - Marty Bowles Edwards

**On motion,** unanimously approved the infant baptism of Thalia Jean Chambers, daughter of Aislinn (D'Auben) Chambers and Michael Chambers for December 1, 2019. Aislinn grew up in our church and church member Pam Paulsen is the grandmother of this child.

- Committee Chairs will maintain a record of Committee Minutes. Those minutes are emailed to Session Members for reading prior to the monthly Session Meeting. These committee minutes will not be stored by the church.
- Active Membership Roll and Baptized Member Roll are under review for consideration of changing our current system.
- Clerk received a note praising the change to a unified single Worship Service format, and the manner in which it was researched and communicated to the Congregation.
- Five of the six assigned conversations have been completed, to share the motions passed at the October 18, 2019 Session Meeting. The sixth and final meeting is scheduled for November 22.
- Pastor Mark and Clerk Marty have requested Presbytery leadership consider participating in a conversation led by an outside Mediator to allow for planting seed of understanding and reconciliation.
  - o It is recommended that the list of questions Session submitted for a Synod Review be addressed as a part of the mediation.
  - o To date, there has been no Presbytery response to Session regarding the questions.
- Results of E-votes shared:

**On motion,** unanimously approved Katrina Williams to become a member of FPC Davenport by profession of faith. The date of baptism and introduction to the Congregation will be determined in the future.

**On motion,** unanimously approved the spending up to \$1000 to bring a candidate for the CE director position to Davenport for an in-person interview.

# **DEACON'S REPORT** – Ted Brown Standing Committee Reports Outreach:

- Blessing Box drive: Volunteers have been recruited to man the Blessing Box drive to occur at KWQC
  TV on Martin Luther King Day, January 20, 2020. A donation box has been set up in the back of the
  Sanctuary.
- Food Pantry collected an unknown amount of money and 91 food items for October. -65 were served at Church's United Dinner.
- Angel Tree project through Bethany Homes this holiday season. Gift tags will begin to be
  distributed between services Sunday November 17. 100 tags are being requested. Gifts are to be in
  the \$45 per child range and are to be returned to Fellowship Hall unwrapped by December 10,
  2019
- Paula Hartmann and Debbie Keenan have agreed to serve as co-chairs of the Outreach Committee for 2020.
- Cocoa and mitten giveaway event will be held December 10, 2019 from 3:00-5:30 outside the southwest corner of the church. Donations are welcome. Anyone wanting to attend is encouraged to do so.
- Boys and Girls Club has severed its ties with the church and has relocated to the J.B. Young School Administration Center. Deacons are no longer providing a Wednesday night meal or providing

homework helpers, though individual church members are welcome to contact Boys and Girls Club directly should they desire to provide those services.

• Outreach is actively searching for a cause to support in place of Boys and Girls Club.

#### Mission Connection:

- Schalk reported on the trip that she, Craig Foster and another made to Guatemala to support our mission for ILUGUA. They had great communication with six outlying communities in the area because their leaders were attending a conference at ILUGUA's center. Deforestation and water shortages continue to be issues they struggle with. The government continues to stifle and undermine ILUGUA leaders.
- The church is no longer supporting AMKA based on recommendations from the Mission Connection committee. It was agreed that the funds left in the AMKA account be sent to ILUGUA instead.
- Kids Against Hunger will be held April 19, 2020 April 21, 2020.
- Tabitha's Circle has 75 items ready to be shipped out for distribution.

#### New and Other Business:

- Pastor Mark for \$200 of the Deacon's discretionary fund to pay to a person who came to the church because he couldn't pay his rent. It was the consensus that while this was acceptable on a one-time basis, these types of requests should generally go through Neighbor to Neighbor. It was also noted that there is now \$800 left in the Deacon's discretionary fund which budgeted on a 'use it or lose it' basis. Brown moved that we give \$400 of the balance in the discretionary fund to Neighbor to Neighbor in November and that, assuming no intervening need arises, we give the remaining \$400 to Neighbor to Neighbor in December. K. Wells seconded the motion. Motion carried.
- Schalk inquired as to whether there are budgeting meetings happening that Deacons should be attending. Brown agreed to inquire at Session next Monday. A discussion was held.

- The committee is moving forward with their search, and will broaden the candidate pool by considering Ordained Pastors.

Total Committed Pledgers 132 for \$481,439

Total Committed Pledger Net Increase of \$46,739 (compared to 2019 Pledge)

- 8 New Pledger \$24,470
- 55 Pledgers increased their pledge total increase \$35,439 (includes \$1,143 increase due to 53 weeks of giving in 2020 vs 52 weeks in 2019)
- 10 Pledgers decreased their pledge total decrease (\$10,549)
- 4 Pledges opted out Lost pledges (\$5,600)
- Note: 2019 Total Pledge Count = 225 for \$658,200
